2 Religious Freedom of Expression Stance - Equality Officer

Proposal: <u>The ISSU holds the belief that every student deserves the right and the freedom to practice and express their religion and that it should be respected within educational settings. This is shown in article 44 of Bunreacht na hÉireann.</u>

Article 44

2 1° Freedom of conscience and the free profession and practice of religion are, subject to public order and morality, guaranteed to every citizen.

Students should be able to express their religious faith through the wearing of clothing and other religious items such as but not limited to hijabs, a kabbalah, a kippah, rosary beads, a kara or a turban. This is subject to health and safety concerns or any other concerns deemed valid by the the school or educational institution. Schools with canteen services should also accommodate students with religious diets including but not limited to Kosher diets, Halal diets or religions that follow vegetarian or vegan diets (ie Hinduism or Buddhism). The ISSU also believe that schools should provide safe and quiet multi-faith spaces for students to avail of for worship during the school day.

Uachtarán Oinigh (in advance via absentee email): I'd recommend one slight working adjustment - changing "This is subject to health and safety concerns for certain things or any other valid concerns of the school or educational institution." to "This is subject to health and safety concerns or any other concerns deemed valid by the school or educational institution."

Equality Officer - reads out stance and accepts recommendations of the Uachtarán Oinigh in advance of the meeting.

7 Role of the Education Officer - Education Officer

Raises concerns of the sharing of education as a remit over 3 positions (Uacharán, Leas Uachtarán, Education officer) but notes that this is because we are an education organisation.

The education officer wishes to create a discussion on the role of education officer.

Uachtarán - raises a concern about getting too specific in the constitution.

Rúnaí - raises concerns about the merging of Rúnaí with Leas-Uachtarán and highlights concerns over the amount of officers on the Coiste Gnó.

9 Strategic Planning Meeting - Uachtarán

Previous Strategic Planning Meeting (SPM) was held in July and was attended by various parties, this time the full board of directors and Coiste gnó will be invited.

The Uachtarán encourages the Coiste Gnó to add availability into the lettuce-meet and invited the Coiste to prep meetings in advance of the SPM.

10 Resignation of the Leas-Uachtarán Update - Uachtarán

Uachtarán updates on the Coiste Gnó on steps taken so far and reads out the recommendations of the Monitoring and Advisory Committee.

Oifigeach na Gaeilge - in favour of holding an Extraordinary Assembly and notes that 21 days is sufficient for election handbook.

Education Officer - raises concerns over quorum, and recognises the need for a back up plan incase quorum is not met.

Communications Officer - raises concern over her capacity with regards to running for an Extraordinary Assembly.

Education Officer - We need to select a Chairperson and Returning Officer as soon as possible.

Welfare Officer - can we place the correct constitution for the role of Leas-Uachtarán in advertisements so as to not create confusion over job descriptions, as they will be running for the position left vacant, and not the position as outlined in the constitution on the website.

Rúnaí - we can also propose a new AA/EA procedure document to clarify future discrepancies.

Proposal: to hold an online extraordinary assembly for the purpose of holding a bye-election for the vacant position of the Leas-Uachtarán, and the possibility of Constitutional Amendments to be approved by the Coiste Gnó by Tuesday the 8th of November.
